## Applicant Declaration

**Yes, I (the applicant) agree:**

1. To UQ communicating with me via electronic means. This may include communications relating to UQ-organised events;

7. If my first preference is unavailable or full, I will be considered for my second preference, if I nominate one. While UQ does its best to accommodate all eligible ESP applicants, if large numbers of applications are received for specific courses, we may not be able to offer all eligible applicants a place.

9. My final passing grade will remain on my permanent record with UQ. All official grades on a student's record may be used to calculate a Grade Point Average (GPA) for applications for study in undergraduate, honours, postgraduate or research studies in the future.
